Assessment Activity: Exit Survey -- May 2017

Please provide a brief name for this assessment activity.	Exit Survey -- May 2017
Describe the assessment method used to assess the learning outcome(s). Provide enough detail so that we understand the nature of the project.	All students registered in SSWG 8504 (Integrative Seminar) are invited to participate in the exit survey. There are two practice behaviors associated with each SLO/Competency. Each student rates their perceived level of ability to perform the given practice behaviors. The benchmark for each SLO/Competency was defined as having 80% or more students rate their ability for the given SLO/Competency at a score of 7 or higher based on a scale of 1-10, with higher values indicating greater confidence in performing the specific practice behavior. The SLOs/Competencies and their associated practice behaviors are all defined by our accrediting body (Council on Social Work Education: CSWE).
What were the findings from this assessment?	This benchmark was achieved for all of the SLOs/Competencies. The lowest score was 82% for the Practice and Research SLO/Competency. All other SLOs/Competencies were above 85%.

Where applicable, give specific examples of changes you are making to the program as a result of your findings.</p>	<p>This result corresponds with the results obtained from the other assessment we used -- field instructor reports. The Practice and Research SLO/Competency has been the lowest scoring in the exit survey reports for several years, but it has consistently achieved the benchmark. This is an issue that the SSW curriculum committee will continue to monitor. There were additional questions requested by the MSW Program Director to assess various options for the development of curricular specializations (i.e. children & families; health & mental health; military social work; trauma focused practice). This information, along with focus group discussions led by the MSW Program Director, will be used in deciding the direction the MSW program will take regarding these specialty options for the students.</p>

Provide enough detail so that we understand the nature of the project.</p>	<p>The instructors at the students' field placements rated the students on various practice behaviors associated with the SLOs/Competencies. Each practice behavior was rated on a 5 point scale, with success for the student on the practice behavior being defined for this evaluation as a score of 5 ("Outstanding") or 4 ("Very Good"). The benchmark for the SLOs/Competencies was having 80% of the students receiving that level score. The SLOs/Competencies and their associated practice behaviors are all defined by our accrediting body (Council on Social Work Education: CSWE).</p>
<p>What were the findings from this assessment?</p>	<p>All of the SLOs/Competencies met the benchmark, with the lowest score being 83% for the Practice and Research competency.</p>
